The Chairman, Sri Vishnu Educational Society, Vishnupur, Bhimavaram

Town & Mandal have applied for conversion of agriculture land Ac. 58-46 Cts. situated in R.S.Nos 62/1 etc., of Kovvada Village and R.S.No.275/3 of Bhimavaram for the purpose of Non-Agriculture. The request of the applicant is found to be consistent with the provision of the Act.
